Mickey L. Washington is a native of Port Arthur and Beaumont, Texas. Mr. Washington obtained his Bachelor of Science in Sociology and a Minor in Health from Texas A&M University in 1990. He went on to play in the National Football League for 8 years and became the cornerback for the Buffalo Bills in Super Bowl XXVIII. Washington received his law degree from Texas Southern University's Thurgood Marshall School of Law.



Mr. Washington is a former investment and business development manager. He holds several honors, including Unsung Hero, All American Honorable Mention, Texas A&M Team Captain, First Team All Southwest Conference and Texas A&M All Decade Team.

In his legal career, Mr. Washington has been employed with the Taylor, Davis and Ernster Law Firm, settling and winning verdicts in Catastrophic Personal Injury, Toxic Tort and Business Litigation cases. In addition, Mr. Washington has been a former Union Representative for the National Football League Association where he was instrumental in the development and negotiation of Free Agent contracts and the Collective Bargaining Agreement between NFL players and the NFL.
